CIRCULAR TO THE PARENTS: RE-OPENING OF SCHOOL (IX to XII) ACADEMIC SESSION 2021-22

Dear Parents & Guardians,

Cordial greetings for a Healthy Life from your School, St. Vivekanand Public School, Sadabad !

As you know that Ms. Aaradhana Shukla, Principal Secretary- Secondary Education (Government of Uttar Pradesh) vide its Notification No. 1467/15-07-2020-1 (52)/2021 Date August 02,2021 has communicated that schools can go for offline classes for children (IX to XII) with effect from *Monday, August 16, 2021*

This is further to our circular informing you about the **reopening of the school from August 16, 2021.** The school send will open in a phased manner with classes IX to XII. We sincerely thank the parents who will their consent for sending their wards to school. We would like to inform the parents that the decision to reopen the school has been taken after a lot of deliberations. We are happy to share with you details of the arrangements that have been made in school to welcome our students. These are in line with the recommendations of the M.O.E. Kindly go through them carefully, we are confident that you will find them to your satisfaction.

To assist the school in its humble endeavor to reopen the school for our children, we solicit 100% cooperation and support from the parents.

In accordance with the Government notification, we expect your support, cooperation and collaboration in observing the appended guidelines in our determination to reopen the school.

1. School Timing: 08:00 a.m to 11:00 a.m. for 10th & 12th Std.

09:30 a.m to 12:20 p.m. for 9th & 11th Std.

- 2. No On-line Classes (IX to XII) w.e.f. Monday, August 16,2021.
- 3. Sanitization of the School Campus and Classrooms is done on a daily basis before and after the school hours.

- 4. **Consent Letter:** No child would be allowed to enter the School Campus without a Consent Letter from the parents. You can download your consent form from school website or in your respective WhatsApp Group and submit it in your class .
- 5. **Potable R.O. Water Facility is Available** in the school. However, children are encouraged to carry their own water bottles.
- 6. **No Sharing of Articles** (pen , pencil, geometry box, water bottles, face masks, etc), would be allowed among children.
- 7. **Covid-19 Health Card for Every Child**. The essential details of body temperature, etc. would be entered at the main gate of the school. Kindly keep a track of the same.
- 8. **'No Mask, No Entry' Policy will be Strictly Followed**. Wearing Face Mask is mandatory.
- 9. Hand Sanitization and Hand Wash Facilities are in Place. However, children are advised to carry pocket hand sanitizers to use at regular intervals.
- 10. **Strict Physical Distancing Policy** would be followed in the School Campus. Those who break this rule shall not be allowed to come to the school.
- 11. **The Mode of Transportation of the Children** would be the responsibility of the parents as the safety of our children is our utmost importance.
- 12. School Uniform is a Must for Off-line Classes.
